

Ordinance / Resolution No. 297 RCW 84.55.120

WHEREAS, the Board of Commissioners (Governing body of the taxing district) of (Name of the taxing district) has met and considered
its budget for the calendar year 2023; and,
WHEREAS, the districts actual levy amount from the previous year was \$\frac{1,380,000.00}{\text{(Previous year's levy amount)}}; and,

additional revenue resulting from new construction, improvements to property, newly constructed wind turbines, solar, biomass, and geothermal facilities, and any increase in the value of state assessed property, any annexations that have occurred and refunds made.
