#### 8. OLD BUSINESS

8.1 Discussion: Wharf Update - Roof & Pile Project

Executive Director Michalopoulos presented the project cost estimator for the re-roof project. Attorney's will review details of the bid to ensure the Port of Coupeville is mitigating risk.

Port of Coupeville staff met with Nickel Brothers to discuss options to raise the wharf building 3 – 4 vertical feet due to rising tides. Executive Director Michalopoulos requested costs associated with this project to seek funding.

The pathway to office at 24 Front Street is failing and will need rebuilding. Staff is starting the permitting process. Project will be executed with Port staff.

Port of Coupeville is currently working on a grant from Friends of Ebey's for the replacement of 24 Front Street wood windows.

8.2 Discussion: Broadband Phase 2 Update

Executive Director Michalopoulos presented an update including the need for a franchise agreement and PSE poll agreement.

8.3 Discussion: Priority Establishment Procedure – Commissioner Callahan

Commissioner Callahan presented the Priority Establishment Procedure to the Board and they discussed how priorities are set on projects. Commissioners will each send items to prioritize to Executive Director Michalopoulos and it will be added to the priority establishment procedure.

#### 9. NEW BUSINESS

9.1 Action: Discussion on need for work session.

Executive Director Michalopoulos presented information on details of payables already budgeted and how the Board reviews vouchers during every session. Executive Director Michalopoulos reviews all invoices and signs off approvals after details determined it is valid for payment. The action item requested is for work session to be eliminated on discussions on vouchers. Intent is for efficiency during open public meetings and keeping topics on high level discussions.

Commissioner Day made a motion to dispense with second work sessions prior to second meeting of the month. Commissioner Mishasek seconds the motion. **Motion passed unanimously.**
