

Ordinance / Resolution No. 245 RCW 84.55.120

WHEREAS, the Board of Commissioners (Governing body of the taxing district) of the Coupeville Port District (Name of the taxing district) has met and considered
its budget for the calendar year; and,
WHEREAS, the districts actual levy amount from the previous year was \$ 384,229.69 ; and, (Previous year's levy amount)
WHEREAS, the population of this district is more than or (Check one) less than 10,000; and now, therefore,
BE IT RESOLVED by the governing body of the taxing district that an increase in the regular property tax levy
is hereby authorized for the levy to be collected in the 2018 tax year. (Year of collection)
The dollar amount of the increase over the actual levy amount from the previous year shall be \$ 3842.30
which is a percentage increase of 1 % from the previous year. This increase is exclusive of (Percentage increase)
additional revenue resulting from new construction, improvements to property, newly constructed wind turbines, any increase in the value of state assessed property, any annexations that have occurred and refunds made.
