## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Port operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of the Port of Coupeville from January 1, 2016 through December 31, 2018.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2018, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Accounts payable – credit cards, travel expenditures and employee reimbursements
- Open public meetings – documentation of minutes, executive sessions and special meetings

## INFORMATION ABOUT THE PORT

The Port of Coupeville provides marina services to central Whidbey Island, located in Island County. The Port also leases property to local businesses in the town of Coupeville. In addition, the Port owns and operates the historic 151-acre Greenbank Farm property and leases offices and shops to small businesses and hosts numerous community events.

An elected, three-member Board of Commissioners governs the Port. The Board appoints an Executive Director to oversee the Port's daily operations as well as its three full time employees and three seasonal, part time employees. For 2016, 2017 and 2018, the Port operated on budgets of \$643,267, \$652,477 and \$631,566, respectively.
