10.1 Discussion: Wharf Update - Roof & Pile Project

Executive Director Michalopoulos provided an update on the Coupeville Wharf pile/cap project. The Pile and Cap permit was obtained. Roof construction/repair is still on schedule. Wall stabilization project engineering will begin in February.

10.2 Discussion: Broadband Phase 2 Update

Executive Director Michalopoulos provided an update on the Broadband Project. He is applying for additional federal funds in the amount of \$1.3 million to \$1.6 million to support design and increased materials cost.

Executive Director Michalopoulos provided an update on the Federal Procurement Policy. Mary is finalizing several points and then a final review is to be conducted by Commissioner Callahan.
