1. CALL TO ORDER

Meeting started at 1:00 PM

2. PLEDGE OF ALLEGIANCE

4. CHANGES TO AGENDA

Commissioner Callahan requested to remove the Executive Session from the agenda.

5. COMMISSIONER ACTION:

7. OLD BUSINESS

7.1 Discussion: AJ Eisenberg Airport – Due Diligence

Executive Director Michalopoulos reviewed the results of the Commissioners task to rate the top priorities of the Due Diligence list. The top three are 1. Ecological 2. Securing Funds 3. Fuel Tanks.

Commissioner Callahan and Commissioner Mishasek discussed their concerns of meeting the diligence due date of 6/3. Executive Director Michalopoulos suggested that the board members contact him directly for assignments to help meet this due date.

7.2 Discussion: Wharf Update

Executive Director Michalopoulos gave updates on the Fuel Tanks, Roof, Piles and Caps, Benches and Walkway projects. Engineers are working on a fiberglass solution for the Fuel Tanks. The construction of the roof will start in May. The Piles and Caps are moving to the bid phase. Benches and walkway are completed.

Executive Director Michalopoulos gave an update on the conduit being installed to supply fiber to the manager shack at the wharf.

7.3 Discussion: Greenbank Farm – Pond Update

Executive Director Michalopoulos discussed the need for bi-annual maintenance and recommended a solution of using boulders along the edges to mitigate pond bank erosion.

8. NEW BUSINESS

8.1 Discussion – Phishing Scams and Risk Management

Executive Director Michalopoulos discussed examples of current phishing scams and risk management solutions.

9. POLICIES AND ADMINISTRATION

9.1 Commissioner Callahan asked Commissioner Mishasek if there were any questions or comments on the draft he provided. Mishasek did not have any at this time.

Joe Andrade – Oak Harbor – Agreed that purchase of the AJ Eisenberg Airport will benefit the community and discussed several benefits to the community.

Suggested a pump out boat would be beneficial for the Coupeville wharf.

Geri Morgan – Oak Harbor – Agreed that a public hearing is a good idea to help educate the community on the benefits of purchasing the AJ Eisenberg Airport.

Commissioner Mishasek, Commissioner Callahan and Executive Director Michalopoulos discussed the need for a public hearing regarding the purchase of the AJ Eisenburg Airport, and the required details of this meeting.
