3.1 EXECUTIVE SESSION - Planned ES Time is 60 Minutes

Per RCW 42.30.110 (1)(b), To consider the selection of a site or the acquisition of real estate by lease or purchase when public knowledge regarding such consideration would cause a likelihood of increased price.

Per RCW 42.30.110 (1)(i), To discuss with legal counsel representing the agency matters relating to agency enforcement actions, or to discuss with legal counsel representing the agency litigation or potential litigation to which the agency, the governing body, or a member acting in an official capacity is, or is likely to become, a party, when public knowledge regarding the discussion is likely to result in an adverse legal or financial consequence to the agency.

No decisions were made during the executive session.

Commissioner Mishasek made a motion to approve and authorize Executive Director to negotiate and sign an agreement, subject to legal counsel review and approval, receiving an assignment of Geri Morgan's right, if she acquires it, to purchase the real property at 1140 Monroe Landing Road, Oak Harbor, Washington which agreement will include payment of \$55,000 to Geri Morgan to reimburse her for the Earnest Money deposit she will pay for the property.
